AN ORDINANCE AMENDING SECTION 52.29 OF THE CITY OF TUSCOLA CODE OF ORDINANCES TO INCREASE THE REIMBURSEMENT AMOUNT FOR SIDEWALK REPAIR OR REPLACEMENT

PREAMBLE

WHEREAS, the City of Tuscola, Douglas County, Illinois, (hereinafter the "City") is a duly established and functioning home-rule municipal corporation; and

WHEREAS, the City has adopted and maintained a policy of assuming a portion of the cost of sidewalk repairs and replacement undertaken by citizens, as specified in Section 52.29 of the City of Tuscola Code of Ordinances; and

WHEREAS, the cost borne by the City is currently limited at \$7.00 per linear foot, not to exceed one-half of the total project cost; and

WHEREAS, the intent of the sidewalk policy is to reimburse one-half of the cost of typical sidewalk construction, which has increased to a current market rate of approximately \$30 per linear foot.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TUSCOLA, DOUGLAS COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE. That Section 52.29 of the City of Tuscola Code of Ordinances be amended in its entirety, now to read as follows:

"52.29. City to Share Costs.

On any sidewalk construction, or on any replacement sidewalk construcito9n undertaken hereafter, the City will assume and agree to pay not to exceed \$15.00 per running foot of the construction cost, not to exceed on-half of the total construction cost thereof, provided that funds are available to the City to pay for such construction or replacement."

SECTION TWO. <u>Severability</u>. Should any part of this Ordinance be declared invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Ordinance.

SECTION THREE. <u>Effect of Ordinance</u>. Except as detailed above, all other Ordinances of the City of Tuscola shall retain their current language and remain in full force and effect.

SECTION FOUR. <u>Effective Date.</u> The City Clerk shall cause notice to be published in a newspaper of general circulation within the County that this Ordinance has been adopted and that copies are available upon request to the City Clerk. In addition, copies of the ordinance shall be posted in the City Hall and the Community Building. The publication shall be made within fifteen (15) days of the adoption of this Ordinance. The Ordinance shall be in full force and in effect twenty five (25) days after said date of publication.
