## Meeting of the Tuscola Sign Board of Appeals and Zoning Board of Appeals.

**Agenda:** The Tuscola Sign Board of Appeals and the Tuscola Zoning Board of Appeals held a public hearing on Thursday, July 23rd at 7:00 P.M., at 214 N. Main, Tuscola IL. to consider three requests.

Date: July 23, 2020

The first is submitted by Love's travel stops and requests a variance be granted for extra square footage, Height, and separation requirements of signs located at 803 Moore Avenue. The signs proposed would exceed the height and size allowed by the City of Tuscola's Sign Code.

**Minutes:** The Sign board of appeals meeting was called to order by Chairman Hilgendorf, at 7:00 PM. Roll call was taken and five members were present. Hilgendorf declared a quorum and continued by reading the requests for the sign variance located at 803 Moore Ave., Also, present was Drew Hoel, City Administrator, and Mike Salmon, City Building Inspector.

Hilgendorf asked the applicants if they would like address the board with their request.

Rick Shuffield, Love's, gave a brief overview of the variance requests and an explanation on I-57 travel and sign heights. He explained that the sign size and height needed was for travelers on the interstate to see and have time to exit safely from the interstate. He explained the directional signs could be lowered to 12 square foot but said having a larger sign is important to keep traffic safe.

Hilgendorf asked if anyone else would like to speak: No public comment.

Hilgendorf submitted a letter into record from Michael Lanman, objecting to the request.

Hilgendorf asked for any more questions. As there were none, Hilgendorf asked for a motion.
