It shall be unlawful to permit a vehicle to remain parked in any parking space in a limited parking zone for a longer period than two hours between 8:00 a.m. and 5:00 p.m. any day except Sundays and holidays.

by physicians on emergency calls.

Any person violating the limited parking time provisions shall be fined \$2 for such offense, provided however, that if the fine is not paid within 48 hours after the date and time noted on the ticket issued for such offense the fine shall be \$5. Each two-hour period, or part thereof, during which the violation continues, shall constitute a separate offense.

SCHEDULE VIII: EMERGENCY VEHICLES.

(A) It shall be unlawful for any person to permit any vehicle to remain parked in any parking area so designated by ordinance as an emergency vehicle parking area, other than a vehicle used by a firefighter, police officer, public works employee, emergency medical technician, or other emergency services provider in response to an emergency.

(B) Any vehicle so parked in violation of this schedule shall be towed and may be reclaimed on payment of any towing and storage fees, if any.

(C) The following areas are hereby designated as emergency vehicle parking areas.
